## **MEETING PLACE & DIRECTIONS**

- Weston Park is situated on the A5 at Weston-under-Lizard, TF11 8LE.
- Please enter through Blymhill Gate by The Granary and park in The Granary car park.
- Head for the EKO banner near the gate by The Granary entrance where our EKO leaders will greet and register your child at **09:00am and 10:30am**.
- Please remember that collection is at 4:00pm at the same place as morning registration

You will be asked to confirm the following:

- Your contact number in an emergency and who will be collecting your child.
- Any ailments or allergies that you have listed.

Food & Drink:

- Please can all children bring a filled drinks bottle (no glass). Water will be readily available to fill up bottles.
- A healthy hot lunch will be provided to ALL children each day.
- We will also be providing snacks during the day.

### **Clothing:**

- Waterproof coats and trousers are ESSENTIAL on wet days as we will stay outside for the majority of the session, whatever the weather. We have plenty of spare kit, if you need anything, please contact us.
- Wellingtons with warm socks or walking boots are best. Trainers can get wet resulting in cold feet.
- Clothing needs to be old, comfortable, warm and easy to move in. Please bear in mind acrylic clothing such as fleeces tends to be warmer than cottons such as sweatshirts.
- Please pack additional warm layers as well as hats and gloves. Children love being outside but can get miserable when they are cold.

## DEPARTURE

- At the end of the session children will be escorted to the **Granary Car Park for 4:00pm**.
- If there is a change to your collection plans, please message the leader asap. DO NOT EMAIL THE OFFICE.

## **BEHAVIOUR MANAGEMENT**

We aim to manage behaviour using clear, consistent and positive strategies. EKO LTD rules are recapped at every session and are discussed regularly.

- Repeated failure to follow rules, endanger themselves, staff and other children will result in the child's exclusion. The parent / carer will be contacted in order to remove their child.
- If staff view a child's behaviour to be socially unacceptable and or abusive the parent / carer will be contacted in order to remove their child
